At its Board of Directors Meeting held on February 14, 2024, MODEC, Inc. decided on a plan for change in its Representative Director, subject to approval at the 38th Ordinary General Shareholders' Meeting scheduled to convene on March 27th, 2024 and approval at the Board of Directors Meeting after the General Shareholders' Meeting.

Further, MODEC, Inc. has announced in its statement dated December 21, 2023 titled "Notice Regarding Transition to a Company with Audit and Supervisory Committee" that it will transition from its current "Company with a Board of Company Auditors" structure to a "Company with an Audit and Supervisory Committee", subject to approval at the 38th Ordinary General Shareholders' Meeting scheduled to convene on March 27th, 2024. At its Board of Directors Meeting held today, MODEC, Inc. decided on a plan to appoint Directors and Audit and Supervisory Committee members following its transition to a Company with Audit and Supervisory Committee.

1. Changes to Representative Director

As MODEC, Inc. starts its Mid-term Business Plan 2024-2026 this year, the changes aim to transition to the new leadership at this timing so that he will be able to lead the implementation of the plan throughout the duration to further drive growth and increase corporate value of the MODEC Group in the mid to long-term perspective.
